香港民研今天下午發放「我們香港人意見群組調查」 和「疫後復聚指數」及介紹民主派初選觀察計劃

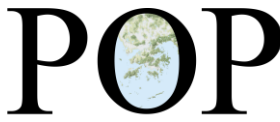

HKPOP will release today afternoon “We Hongkongers Panel Survey”, “Post-Epidemic Gathering Resumption Index” and introduce the Democrats Primary Election Observation Project

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) re-launched its “We Hongkongers” Initiative, to invite Hong Kong people to suggest current affairs survey questions to HKPOP via its Facebook page and then cast their votes online to select the question(s) for its “We Hongkongers Panel Survey”, and then release the results. This week’s survey is the sixth round and the question is: “If the Central Government formally implements the Hong Kong National Security Law, how much do you support or oppose the U.S. Government to revoke Hong Kong’s preferential treatment from that given to Mainland China according to the ‘United States - Hong Kong Policy Act’, including a separate customs territory, bilateral economic and trade relations, free currency conversion, visa entitlements, etc.?” The results will be announced **today (July 3) afternoon**.

HKPOP will also release the latest reading of the “Post-Epidemic Gathering Resumption Index” (PEGRI) today, while its reading today (July 3) is 63.3.
