

採訪邀請 (更新)**香港民研今日發放「我們香港人意見群組調查」，
多項「疫後復常指數」及公佈有關評分量尺實驗之細節**

香港民意研究所之香港民意研究計劃 (香港民研) 將於今日 (8月14日) 下午舉行發布會，發放「我們香港人意見群組調查」及多項「疫後復常指數」，同時公佈「民間發起民研呼應」評分量尺實驗之細節、回應近日有研究機構涉嫌自我審查事件及介紹民研即將推出的 Twitter 宣傳平台。

香港民研於五月底宣佈重整「我們香港人」計劃，每星期透過研究所的 Facebook 專頁邀請市民就社會時事議題提供意見題目，然後進行網上投票，並把票數最高的一至多條題目納入「香港民研意見群組」調查，然後公佈結果。本星期進行的是第十二輪調查，題目為：「根據現行條例，合資格選民必須『通常在香港居住』。你有多支持或反對修改條例，讓長期不在香港居住的香港永久性居民擁有投票權？」截至今天上午 11 時，已有超過 9,500 人參與調查。結果將於今日下午公佈。

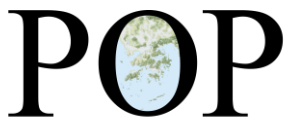

Press Invitation (Update)

HKPOP will release today the “We Hongkongers Panel Survey”, some “Post-Epidemic Normality Resumption Indexes” and announce details of our Rating Scale Experiment

The Hong Kong Public Opinion Program (HKPOP) under the Hong Kong Public Opinion Research Institute (HKPORI) will hold a press conference **today (August 14)** afternoon to release the “We Hongkongers Panel Survey”, some “Post-Epidemic Normality Resumption Indexes” and announce details of our “From the People, For the People!” Rating Scale Experiment, responds to a recent incident of alleged self-censorship by a research institution and introduction of HKPOP’s upcoming Twitter publicity platform.

HKPOP has re-launched its “We Hongkongers” Initiative in late May. Every week we invite Hong Kong people to suggest current affairs survey questions to us via its Facebook page, then cast their votes online to select the question(s). This week is the twelfth round and the question is “According to current legislation, eligible voters must have ‘ordinary residence in Hong Kong’. How much do you support or oppose amending the legislation to allow Hong Kong permanent residents without ordinary residence the right to vote?” Up to 11am this morning, over 9,500 citizens have participated in the survey. The result will be announced **today** afternoon.
